## Important Points Regarding the Application Process

### Event dates

February 19,

9:00 Start of individual marathon, two-person marathon relay  
10:00 Start of Fun Run  
10:45 End of Fun Run  
15:00 End of individual marathon, two-person marathon relay

### Rules of competition

The rules of competition are established in accordance with the 2016 Japan Association of Athletics Federation Rules of Competition as well as the matters of note for competition of the Event.

#### Course

- (1) Marathon  
Starting in front of Kitakyushu City Hall and ending in front of the Kitakyushu International Conference Center, the course is recognized by the Japan Association of Athletics Federations and AIMS.
- (2) Two-person marathon relay  
The two-person marathon relay follows the same course as the individual marathon, with the relay point being near the West Japan General Exhibition Center.
- (3) Fun Run  
Starting from and finishing at the intersection near the entrance of the Kitakyushu International Conference Center  
\*The start point is subject to change due to road construction.

\*1 Including the Kitakyushu Citizen Quota of 2,000 participants and speed runner quota of 500 participants

\*2 Including the sports promotion runner quota of 300 persons (teams).

\*3 One team made up of two members will run a total of 42.195 km. A sash will be handed to the second runner.

\*4 3 km and 5 km courses will be set up for the Fun Run allowing participants to select the distance they want to run on that day. 3 km course will be set up for elementary school students in consideration of effects on the body. In addition, measurements of the record and public recognition will not be conducted.

\*5 Time counted towards the time limits is calculated based on the time when the starting gun goes off.

\*6 Barriers and road closures will be established for the individual marathon and two-person marathon relay based on traffic, security and the race itself. If any delays occur besides those attributable to barriers and road closures, the race may be suspended. If the race is suspended, participants are to follow the directions of officials and board one of the tour vehicles. The following are barrier locations and road closure times (scheduled).

\*7 If the first runner of a two-person marathon relay team withdraws, the second runner will simultaneously start with other runners from the relay point at 12:00 p.m. In that case, the team will not be regarded as having finished the relay.

\*8 Participants in the Fun Run will be asked to drop out if they have not completed the course within 45 minutes of the starting gun. Once eliminated, they must wait on the sidewalk.

### Treatment of personal information

- (1) The organizers recognize the importance of personal information and strive in every way to comply with laws and the like as they relate to this information, and strive to handle personal information based on their own privacy policies.
- (2) With the aim of improving services provided to event participants, personal information will be provided on participation, reporting race times and related information, providing services from groups offering support and cooperation, as well as affiliated organizations, publishing race times (rankings, etc.), reporting to the Japan Association of Athletics Federation and survey questionnaires.
- (3) The organizers may contact participants regarding the information in the application.
- (4) This event may be broadcast on television and video may be distributed on the Internet.
- (5) Use of video recordings of the event by any third party without the express permission of the organizer (including distribution of images and video on the Internet) is prohibited.
- (6) Video recordings, photos, articles and personal records, etc., may be published in advertising materials including event programs and posters, and in media including television, radio, newspapers, magazines and on the Internet, by organizer approved third parties for the purpose of administration, advertisement, etc.

### Entry qualification

- (1) Marathon  
Participants must have been born on or before April 1, 1998.  
1. Registered participants competitors registered with JAAF for FY 2016  
2. General participants competitors not registered with JAAF  
1 and 2 include both Japanese and non-Japanese competitors with race times of five hours 50 minutes or less.
- (2) Two-person marathon relay  
Participants must have been born on or before April 1, 1998 and must have a time of five hours 50 minutes or less in a two-person relay race. Mixed gender teams may compete but supplemental registration is not permitted.
- (3) Fun Run  
Participants are to be boys and girls in elementary school who are capable of running either 3 or 5 km in 45 minutes or less.  
For (1) through (3) above, [1] a disabled person who is unable to run alone may register up to two escort runners (however, only one escort is allowed per runner). For details regarding the registration method, information will be provided in January only to those who have expressed the desire for an escort runner in their application. Guide dogs cannot serve as an escort for a runner. [2] Participation using a wheelchair is not allowed.

### Prizes for Participation

- (1) Individual marathon, two-person marathon relay

Finishers/medal, finishing certificate (to be sent at a later date)  
\* Competitors in the two-person marathon relay will be given the sashes that they used in the event.

### Public recognition

- (1) Individual marathon: awards for top eight finishers in men's and women's categories
  - (2) Age groups: awards for top three finishers in different age categories (24 or younger, five-year age intervals from 25 to 74 years of age, and 75 or older)
  - (3) Two-person marathon relay: awards for the top three finishing teams in different pairing categories (men's pairing, women's pairing, mixed pairing)
- \* For both (2) and (3) an honorable certificate will be sent out to participants, but no ceremony will be conducted
- \* No awards will be conferred to Fun Run participants.

### The starting line

In order to ensure a safe, smooth start, runners in the individual marathon will line up to start the race in blocks of runners based on finish times recorded in their applications, regardless of whether they are registered competitors or general competitors.  
**Do not submit a finish time largely different from actual running ability. Otherwise this may lead to serious problems in regards to safety.**  
Participants who have not noted their finish times will begin the race in the last block of runners.  
Two-person marathon relay runners will start the race at fixed intervals.

### Attire

Registered participants should select wear becoming their status as competitive runners. Other participants should refrain from wearing anything that would be deemed inappropriate at a sporting event, or any attire that other runners and supporters would find offensive or dangerous.  
Please note that, on the day of the race, runners may be stopped from participating in the race at the organizers' discretion.

## Miscellaneous

- (1) If the Event is cancelled due to causes not ascribable to the organizer, participation fees, handling fees, fees for number cards with printed nicknames and donations to sports promotions shall not be returned in principle.
- (2) Participants are to train sufficiently and receive a medical exam and take other appropriate measures to assure that they are in top physical condition prior to participating in the event.
- (3) Participants are not to wear clothing or other items on the event grounds (including on the course) bearing designs, trademarks or advertisements with company or product names for advertising purposes.
- (4) The organizers will provide for the transportation from the starting line to the finish line of the luggage of the leading runners in the individual and two-person marathon relay marathons. Only items that can fit into the pouch of a handbag that is provided at registration can be accepted. Arrival of the handbag may be delayed due to road or traffic conditions en route to the finish line.
- (5) No parking is provided at the event site so participants are to commute by public transit. Depending on road and traffic conditions, public transit may not be on time. Please note that the organizers cannot assume any responsibility for this.
- (6) If some emergency, such as an accident or fire, should occur during the event there is the possibility that emergency vehicles will need to pass through the area. If this should be the case, the event will be temporarily suspended in accordance with the directions of the staff.
- (7) The organizers may carry out consignment sales of photos and other event-related items.
- (8) In addition to the points noted above, participants are to act in accordance with any instructions regarding items related to the event provided by the organizers.
- (9) Formal receipts for charges
  - Payment by credit card  
No formal receipt will be issued. Please refer to your credit card company account statement and invoice.
  - Payment by wire transfer or at a convenience store  
No formal receipt will be issued. The carbon copy of your bank deposit payment slip is to serve as your receipt.

## Things to remember when applying

- (1) Any application that falls under either of the following categories will be rejected.
  - Applications where the same person is signed up more than once for the same event. (Applications where the same person is signed up individually and with a group and the same person is signed up by multiple groups are included.)
  - Applications where the same person is signed up for multiple events.
- (2) Applications submitted outside of the application period will be considered invalid. Any such applications will not be used in any drawings and the application fee will not be returned.
- (3) All applicants (for the group application and two-person marathon relay, this will be the designated representative) will be notified of the results of the drawing by post or e-mail. However, please be aware that should this notification not arrive or be late in arriving, no second notice will be sent to either the home or email address.
- (4) Participants cannot use substitute athletes or transfer competitive rights to others. Should a participant attempt this type of action, he or she will be disqualified from the event. Upon disqualification, the organizers will not provide any compensation or refund any monies.
- (5) Applications may be delivered late due to circumstances related to postal delivery or Internet servers or other devices, etc. The organizers cannot assume any responsibility for such lateness of delivery.
- (6) When applying online, sometimes a successful application cannot be made due to problems related to the computer, OS or browser that is used. To find out more about the operating environment (OS, browser), please check the event website.

## Application terms

Before applying to participate in the event, the person interested in signing up must consent to the following rules that govern the application process.

- (1) In case of occurrence of illness, loss of valuables or some other accident, the organizers cannot assume responsibility for anything other than taking simple emergency or first aid measures.
- (2) Changes to the event, changes or corrections to applicant details, cancellations and group member changes will not be accepted after application for participants who applied via payment by wire transfer, or after the application period ends for participants who applied via the Internet.
- (3) Persons who falsified their age, gender and/or address, etc., and participation of a person other than the applicant (unauthorized participation) will not be permitted. In such an event, participation fees, handling fees, fees for number cards with printed nicknames and donations to sports promotions shall not be returned in principle.
- (4) If the event is cancelled due to earthquake, wind or flood damage, severe weather, snowfall, incident, accident or epidemic, etc., participation fees, handling fees, fees for number cards with printed nicknames and donations to sports promotions shall not be returned in principle.
- (5) Excess or duplicated deposit monies will not be refunded.
- (6) The publication rights and rights of use of any video recordings, photos or news articles about this event, or otherwise any publication of the applicant's name, age or address (name of country, prefecture or municipality) on television, in newspapers or magazines or on the Internet will remain the property of the organizers.
- (7) The organizers will comply fully with privacy laws to protect the personal information of entrants.
- (8) This event will be carried out in accordance with all applicable domestic laws.
- (9) Minors must gain the consent of a guardian pursuant to filling out this application form.
